### **National Judge (NJ):**

Pre-Requisites: to have attended an ISA Judges Seminar and attained a test score of National standard, have attained extensive protest committee experience. Consideration will be given to the references from other race officials.

### **Regional Judge (RJ):**

Pre-Requisites: to have attended an ISA Judges Seminar and attained a test score of Regional standard, have attained extensive protest committee experience. Consideration will be given to the references from other race officials.

### **Local/Club Judge (LJ):**

Pre-Requisites: to have attended an ISA Judges Seminar and have attained protest committee experience at a range of local and regional events. Consideration will be given to the references from other race officials.

In all cases consideration will be given to event reports and reports from supervising race officials.

The ISA Judges and Umpires Advisory Group will determine the grade of appointment. Appointments are valid for four years, except for candidates over 70 years when appointments are for 2 years, and may be reviewed and updated annually subject to an ISA Race Official Event Report being sent to the ISA.
